- 4. Dave Tatro is preparing the vehicles for winter.
- 5. John Dunn asked Dave Tatro to consider what he will need to work on next year and what funds will be needed for next year's budget. Dave Tatro feels the dead trees will be an issue in future years. Next year he will be doing the chip seal and shim project on East Road which is funded by a grant and ARPA funds.
- 6. Dave Tatro feels if one of the local gravel banks shut down, it will have a huge impact on the town to haul gravel in.

## MUNICIPAL IMPACT QUESTIONNAIRE

#### FIRE TRUCK LOAN

Bill Levine explained that the bank needs a town vote supporting the purchase and financing of the new fire truck.

MOTION by Mike Denault to sign the warrant scheduling a special town meeting to purchase the fire truck for the sum of \$526,515.98 and borrow a sum not to exceed \$270,000.00 for a term of five years at a rate to be determined, and reserving the ability to change the town meeting date if the school gym is not available. SECONDED by John Dunn. All in favor. Motion APPROVED.

#### ST. JOHN BOSCO CHURCH

The Selectboard decided not to follow through with the purchase due to the costs involved.

### ZONING BOARD OF ADJUSTMENT

Nancy Bushika noted that the Zoning Board of Adjustment meeting for the sign permit will be Tuesday, November 12, 2024 at 6:30 p.m.

#### **FEMA**

Lori Shepard reported that all of the filings for last July's flood have been sent to FEMA. Lori Shepard was able to submit over \$4,800.00 representing time spent in administering the grant for reimbursement.

## **RUNOFF ELECTION**

The recent election resulted in a tie for the Justice of the Peace position. State law requires a runoff election to determine the winner. The town clerk will be scheduling the runoff election next week and it will be held soon.

#### HALLOWEEN TRICK OR TREAT

Laura Champagne stated that trick or treat went very well. The Stamford Ridge Riders handed out candy. The fire department was also there with flashing lights. There was a great turnout.

#### CHRISTMAS TREE CEREMONY

Theresa Denault will not be organizing the tree lighting ceremony this year. If someone else is interested in taking over, Mike Denault is willing to set up the Christmas tree. Nancy Bushika thanked her for the work she put into the ceremony each year.

#### **EXECUTIVE SESSION**

The Selectboard entered executive session at 7:05 p.m. Lori Shepard was invited briefly to participate and then left the executive session.

MOTION by Nancy Bushika to exit executive session. SECONDED by Doug Wright. All in favor. Motion APPROVED. The board exited executive session at 7:23 p.m. No action taken.

MOTION by Mike Denault to adjourn. SECONDED by John Dunn. All in favor. Motion APPROVED. The meeting ended at 7:25 p.m.

## **REMINDERS**

- 1. Tax bills have been issued and are due in hand by 8 p.m. on Thursday, November 21, 2024. By town vote, postmarks will not be accepted. Any unpaid tax will be subject to a one-time 8% penalty and 1% interest per month for the first 3 months and 1.5% interest per month thereafter until paid.
- 2. Townspeople should sign up with the state's free communications network, VT-Alert. You can sign up at vtalert.gov to receive notifications. You can choose how you would like to be alerted (phone call, text or email) and can choose what type of alerts you would like to receive, i.e. weather, road closures, public health, etc.
- 3. Anyone interested in applying for the part-time Assistant Assessor Clerk position should submit a letter of interest to the Selectboard.
