# TOWN OF STAMFORD SELECTBOARD MEETING February 2, 2023

Nancy Bushika called the meeting to order at 6:30 p.m., opened with the Pledge of Allegiance, welcomed everyone, and read a statement with procedural rules for the meeting. Additional correspondence was added to the agenda. There were no changes to its order.

### HAZARD MITIGATION PLAN BIDS

The Selectboard received three bids: one from Allison Strohl at the Bennington County Regional Commission in the amount of \$9,889.00; one from Shawna Pinette of Threat Owl, LLC in the amount of \$9,600.00, and one from Stephanie Magnan at Seam Solutions in the amount of \$9,900.00. The board members would like time to review each bid. They will reconvene on Tuesday, February 7, 2023 at 2:30 p.m. to discuss the bids in detail.

### **MINUTES**

MOTION by Mike Denault to accept the regular meeting minutes of January 19, 2023 as written. SECONDED by Pam Tworig. All in favor. Motion APPROVED.

#### SELECTBOARD ORDERS

The Selectboard reviewed and approved the following orders:

# **ROAD CONDITIONS**

Dave Tatro asked the board to consider setting money aside for the highway department. He felt there are a lot of needs that he has been hesitant to ask for which would be much better than \$40,000.00 on the sheriff. The loader is 30 years old, the heating system at the garage is inadequate, the garage ceiling could be lowered along with some insulation and in five years the town will need another plow truck. The \$40,000.00 to increase the sheriff's patrol time is fruitless when compared to what improvements could be done in the highway department. Pam Tworig felt they were two separate things and that his concerns were valid. The board considered a warrant article for the highway department. Mike Denault believes that another \$40,000.00 might pay for nine more hours of patrol time per week at best. For every three hours of patrol time, the sheriff's department charges one hour of travel time. Dan Potvin suggested cancelling the warrant article to increase the sheriff time and replacing it with a warrant article to increase the equipment replacement fund. Pam Tworig suggested keeping both warrants and letting the voters decide. Mike Denault noted that the increases in the budget are directly related to the cost of resources like salt, sand and fuel. He felt the current 13 hours of patrol time already provides a speeding deterrent since you never know if or when the sheriff will be in town. It was his opinion that paying an additional \$40,000.00 would not provide enough patrol time to make a difference and he understood Dave Tatro's argument that \$40,000.00 could be better spent for an actual highway need.

He asked for a good reason to justify how another nine hours of patrol time would benefit the town. No one had any strong reasons. Natalie Yorke felt increased hours would help and she would like to hear what the sheriff has to say at the next Selectboard meeting. Kurt Gamari suggested contacting Efficiency Vermont for an energy audit. They also might have grant funds or other assistance available to make energy upgrades at the garage. Nancy Bushika liked the lively discussion.

#### RECYCLING

Nancy Bushika attended the quarterly Alliance meeting. Recycling expenses are up overall 11%. Each member town will need to approve an amendment to the Solid Waste Plan because when the permanent household hazardous waste facility begins operating, they won't be holding the three Household Hazardous Waste days per year. The board will discuss this further at the next meeting.

### **EMERGENCY MANAGEMENT**

Bill Levine suggested moving the regular transfer station hours from Saturday to Sunday this weekend since it will be so cold. The board felt it will be hard to get the word out in time and didn't know if the recycling monitors would be able to work on Sunday. No change was made.

# SELECTBOARD REPORT

The report was reviewed and finalized.

### WARNING FOR THE TOWN OF STAMFORD

The Selectboard added an article to put an additional \$40,000.00 into the equipment replacement fund. MOTION by Dan Potvin to accept and sign the warning as revised. SECONDED by Pam Tworig. All in favor. Motion APPROVED.

# **2022 AUDIT**

MOTION by Mike Denault to sign the engagement letter for the firm of Love, Cody & Company to conduct the 2022 audit of town accounts. SECONDED by Pam Tworig. All in favor. Motion APPROVED. This confirmation agrees to provide the auditors with all information necessary to conduct the audit at a cost of \$13,125.00. Last year the cost was \$12,000.00.

### UNIFORM MUNICIPAL EXCESS WEIGHT PERMIT

MOTION by Nancy Bushika to approve the Uniform Municipal Excess Weight Permit application from Newport Sand & Gravel Co., Inc. / Carroll Concrete Co., Inc. SECONDED by Pam Tworig. All in favor. Motion APPROVED. The appropriate fee and insurance information was received from the applicant.

### NATIONAL FOREST ASH TREE TREATMENT

Pam Tworig consulted with the National Forest regarding their plan to treat ash trees in Stamford. They intend to treat up to 30 trees within a 31 acre area by injecting a liquid pesticide into the tree. They hope this practice will save ash trees that are dying from the emerald ash borer insect. Pam Tworig feels it is important for the town to have some control over what the National Forest does.

# **SNOW PLOWING**

Natalie Yorke noted that it is illegal to plow snow across town roads yet a lot of people are doing it. Dave Tatro acknowledged that when they leave a lot of snow in the road where he has already plowed it can be irritating.

# TOWN OFFICE MAIL SLOT/DROP OFF BOX

Pam Tworig would like the mail slot to be more secure. An estimate has been requested for the work.

### **VOTERS AT TOWN MEETING**

Only registered voters can participate and vote at town meeting. Pam Tworig asked how it is handled. Bill Levine knows most people in town. Nancy Bushika noted that some towns check voters in as they enter and give cards or voting paddles that you raise to vote. Pam Tworig was in favor of the idea.

#### DOG ORDINANCE

Luke McKay said the Dog Ordinance is outdated and asked the Selectboard to begin the review process.

MOTION by Mike Denault to recess the Selectboard meeting until Tuesday, February 7, 2023 at 2:30 p.m. SECONDED by Dan Potvin. All in favor. Motion APPROVED. The meeting ended at 8:25 p.m.
