## HAZARD MITIGATION PLAN BIDS

The Selectboard reviewed the three bids they received:

Allison Strohl at the Bennington County Regional Commission in the amount of \$9,889.00; Shawna Pinette of Threat Owl, LLC in the amount of \$9,600.00; and Stephanie Magnan at Seam Solutions in the amount of \$9,900.00.

Nancy Bushika liked the bid from Stephanie Magnan but the distance could be difficult as she is from Barre, VT. Mike Denault felt it is good to have a relationship with the company. Pam Tworig said the BCRC helped the town update the Zoning By-laws and she feels they did a lousy job. She noted that they did our last Hazard Mitigation Plan and probably still have the form on their computer so it will just need some tweaking, but that savings isn't reflected in their bid. Nancy Bushika didn't like the BCRC's completion timeframe of 18 months. Bill Levine stated the Hazard Mitigation Plan is important because it entitles the town to an additional 5% in FEMA funds in the event of an emergency. Bill Levine has worked with Allison Strohl for over ten years and recommends that the Selectboard choose the Bennington County Regional Commission bid.

MOTION by Nancy Bushika to accept the bid from Allison Strohl at the Bennington Country Regional Commission in the amount of \$9,889. SECONDED by Pam Tworig. All in favor. Motion APPROVED.
